ADDRESS BY HON. IGNATIUS BAFFOUR AWUAH (MP), MINISTER FOR EMPLOYMENT AND LABOUR RELATIONS AT THE OPENING CEREMONY OF JUSAG'S 6TH TRIENNIAL DELEGATES' CONFERENCE HELD ON TUESDAY, 8TH MAY, 2018 AT THE AUDITORIUM OF UNIVERSITY FOR DEVELOPMENT STUDIES, WA CAMPUS AT 9:00 AM.

Mr. Chairman, permit me to also use this unique opportunity to pay my respect to the first gentleman of our land, H.E. the President, Nana Addo Dankwa Akufo-Addo and to thank all dignitaries present here today for taking time out of their busy schedules to join us grace this Conference.

The theme for the session "Deepening the integrity of the Judicial Service: the Role of JUSAG" is more than apt and fit-

Decent work sums up the aspirations of people in their working lives. It involves opportunities for work that is productive and delivers a fair income, security in the workplace and social protection for families for which pensions are integral. Government is ever committed to ensuring that, all these are in place within the medium to long term. This, we envisage will facilitate the attainment of full and productive employment and decent work outcomes for all men and women within JUSAG, including young people and persons with disabilities and equal pay for work and value. Against this backdrop, we are ready to dialogue with JUSAG to critically examine the conditions of service for improved service delivery.

Mr. Chairman, Distinguished Invited Guests, Ladies and Gentlemen, as I bring my address to an end, I cannot conclude without emphasizing the importance of Social Dialogue in the

World of Work today. Social dialogue has been a powerful tool in addressing most challenges within the labour front as well as promoting harmonious industrial relations among social partners. We cannot take for granted the relative industrial peace and labour front tranquility prevailing currently. It is not a coincidence neither is it the hard work of a single group but rather our collective effort as tripartite partners. I am pleased that, delegates and observers here present, who are drawn from all the JUSAG fraternity have assembled to deliberate and share experiences towards their contribution to Ghana's stability. We assure you that, government takes serious cognizance of your contributions to the world of work and the economy as a whole. We encourage you to be unwavering and open-minded in your deliberations as interactions of this nature could be timeconsuming and compel you to be irresolute.

It is my fervent expectation that, this triennial conference will reflect concerns of JUSAG as well as meet the objectives of the meeting. Let's continue to engage, collaborate and share experiences towards the common goal of ensuring that, JUSAG's

role in deepening the integrity of Judicial Service come into fruition.
